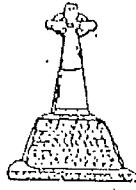

MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD  
ON TUESDAY 10<sup>TH</sup> APRIL 2012 AT BRYMBO ENTERPRISE CENTRE.

The minutes of the meeting of 13th March 2012 were confirmed as a true record and signed by the Chairman.

The Chairman opened the meeting by thanking all Community Councillors who were retiring at the end of their term of office for their work over the past four years, especially those who had given many years of voluntary service over a great length of time, and who were now stepping down. He wished everyone the best at the next election. As the period of purdah had now been entered into, the Chairman advised all members and members of the public that purdah rules would be strictly adhered to during the meeting.

The Chairman asked if any members of the public wished to speak. Mr Bickerstaff from Tanyfron said that he had read a report in the local paper regarding a skate park in Brymbo, and said he wished it noted that no more money should be spent in Brymbo until the MUGA in Tanyfron had been completed.

Mrs Jones a resident of Brymbo handed the Chairman a petition which had been signed by residents of Brymbo with regard to asking the Community Council to support their project of building a skate park in the village. Cllr Woodfine-Jones said he would formally accept the petition on behalf of the Community Council and told Mrs Jones that the Community Council was happy to offer their support to the children of the village.

## **2. POLICING**

PCSO Rhys Rushby attended the meeting and introduced himself. He would be covering the Brymbo ward for the next six weeks as changes were being made during the month of May. He read out the statistics for the month and passed the new form around which was now used by all PCSO's in the area to provide statistics.

Brymbo /Tanyfron- 3 Violence against a person, 2 Burglary dwelling, 2 burglaries bother than a dwelling, 1 theft from vehicle, 2 Theft and handling and 9 Criminal Damage.

Bwlchgwyn –No statistics available.

PCSO Rushby said that there had been numerous reports of damage to wing mirrors during the month in Brymbo.

Cllr B Stapley asked if he had any more information on a wheelie bin that had been set on fire, however was told there were no new leads.

With regards to the attempted theft of the horse in Minera, PCSO Rushby said that the police did run a horse watch scheme. Cllr Tilston asked if any posters were available and if so he would place them in the noticeboards of the village.

## **3. COUNTY BOROUGH COUNCILLOR'S REPORTS**

Cllr Rogers said that new fencing had been completed at Edwards Avenue and landscaping at Morse House had been carried out. With regards to the Communities First project, the Welsh Government had rejected the Council's proposals. As a result this may affect the eligibility of funding. A report was due to be given to the Executive board at the end of the month, and a decision made. Cllr Stapley said that he was very annoyed about the situation, as the Welsh Assembly would not look at anything else, whilst they should be looking at what works on the ground. Cllr Rogers said that the gym had now re-opened at the Enterprise centre and Cllr Birch asked if the existing equipment was being used as he had heard it had been sold. Cllr Rogers said that he was not sure.

Cllr Rogers said that WCBC were to work with residents of Cae Merfyn as disagreements had arisen with regards to the moving of equipment.

Cllr Kelly pointed out that the Owain Glyndwr Scheme was being launched again if Brymbo had any site it would like considered. The closing date was the end of May

Cllr Kelly said that the rights of way for the application for a bridleway at Nant y Ffrith had not been approved.

Cllr Kelly told members that an attempt had been made to take a horse from a field in the Minera ward. Cllr Woodfine-Jones asked Cllr Tilston if he could advise the Residents Association of this.

## **4. CAMBRIAN HOUSE**

Cllr Monti said that he had met with the Valuation Officer the previous week. The Clerk had received a form through the post and Cllr Shone said he would complete this. Cllr Shone said that a full report on Cambrian House would be



given to members once the situation with the rates had been resolved. Cllr Birch wished to re-iterate that a vote had been taken to sell the building. Cllr Woodfine-Jones said that as a tenant was still in the workshop, advice should be taken as the Council should not contravene the law with regards to having a tenant in the building and putting the building up for sale.

#### **5. ROADS**

Cllr Rogers said that Tanyfron Road was to be re-surfaced following the re-surfacing of Bryn Gwenfro.

Cllr Kelly said that with regard to the junction shared by the A483 and A525, he had met with Darren Williams of WCBC. In order to try to alleviate the problems around the hospital, traffic would be sent down to the new roundabout and would not have to stop at the lights.
