MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY MARCH 10 2009 IN THE ENTERPRISE CENTRE BRYMBO.

Apologies for absence had been received from Cllrs T Birch, D Griffiths and K Monti.

The minutes of the meeting held on 10 February were confirmed as a true record and signed by the Chairman.

#### 2. POLICING

Brymbo- There was 1 reported incident of criminal damage to a motor vehicle, 1 theft and for other incidents of criminal damage.

Tanyfron- There was 1 assault, 1 common assault and 1 arson reported. Bwlchgwyn- There were no incidents reported.

Cllr Rogers said that he had witnessed anti-social behaviour when youths were leaving the Community Centre. PCSO Hellyn said that no reports had been received by the police. Concerns were raised by PCSO Hellyn regarding communications between the Community Council and the police as P C Hughes was now on area car duty. Cllr Tilston offered to meet with P C Hughes to see what the Council could do to achieve better communication with police representatives.

#### 2. CAMBRIAN HOUSE

The meeting scheduled to take place before the Community Councils monthly meeting had been cancelled at short notice as 1 officer from WCBC was unwell. Cllr Rogers said he would pass on the Councils disappointment as many Councillors had not been informed in time.

# 3. COUNTY BOROUGH COUNCILLORS REPORTS

Cllr Rogers said that the housing environmental scheme at Morse House was nearing completion. A litter picking up day had been organised for Saturday 21 March beginning at 9a.m.Cllr Rogers said that the lease at St John's churchyard was due to expire this year and WCBC should bring it up to standard before it does. The wall needed fixing and slabs replacing and tarmacing needed to be done. Cllr Shone said that vandelism was a concern and perhaps signs could be placed to deter people from damaging the gravestones. Cllr Rogers reported that the legal agreement was near to being signed for the MUGA at Argoed. Cllr Rogers proposed that the Community Council donate £200.00 to assist with Tanyfron's mother and toddler group. All councillors were in favour of this proposal. Cllr Kelly said that money from the environmental scheme was to be increased and that it would be spent in the wards. The youth scheme provision was an ongoing battle . It seemed there was dupilcation in the provision in some wards to the detriment of other wards. Cllr Woodfine-Jones said that he had secured £5000.00 of grant aid to hopefully get the playscheme up and running. The playscheme would run for children between 8-15 years old with supervised play leaders in charge. Unfortunatley at present Cllr Woodfine-Jones said that he was £2000.00 short in funding but would keep working at it.

#### 4. ROADS

Cllr Woodfine- Jones said that problems were arising from the cutting of hedges by turbo cuttters. Whilst the hedges were being trimmed the matter of clearing up the trimmings was a problem. Geraint Smith from Streetscene had been sending out sweepers whenever it was possible and the Chairman thanked Streetscene for their assistance.

#### 5. BUS SHELTERS SERVICES AND STOPS

A site meeting had taken place on Park Road re the new Bus Shelter and no further complaints had been received.

#### 6. PLAYINGFIELDS AND PLAYGROUNDS

Cllr Rogers said that WCBC were putting 1 piece of play equipment in at Tanyfron and match fund one at Brynyffynnon. This play area was to be removed, however will remain at present. Councillors discussed whether or not to fund the playarea in Broughton as Broughton community Council had refused. It was suggested by Cllr Tilston that if funds were available it should be considered.

#### 11. TIDY TOWNS

Planters had been ordered for Tanyfron and Brymbo from the Tidy Towns grant. Cllr Woodfine-Jones was placing an order for Bwlchgwyn after agreeing that they would be placed at the entrance to Bwlchgwyn and by the bugalows of the elderly residents. Cllr Stapley mentioned that further aid could be obtained from a B&Q fund. Cllr Rogers proposed that £750.00 should be given from the Brymbo Environmental Fund towards the Tidy Towns sceme and this was seconded by Cllr Woodfine-Jones. It was agreed that £750.00 would be split equally between the 3 wards.

#### 12. RISK ASSESSMENT

It was decide that the sub-committee would meet to discuss the risk management strategy before the next monthly meeting.

13. BRYMBO STEELWORKS SITE LIAISON COMMITTEE Cllr Rogers said that the committee had met the previous night and plans for a supermarket had been discussed for later on in the year. The committee were all in favour of supporting the Spine Road with involvement from WCBC. Cllr Shone said that at present it seemed that one half of the village was disconnected from the other and the Spine road was a necessitty.

### 14. AFTER SCHOOL CLUB

A letter was read out by the Chairman requesting financial assistance for the after school club .A request for £1400.00 was asked for. Cllr Rogers proposed funding of £500.00 and was seconded by Cllr Davies . It was agreed that £500.00 would be given from Brymbo Environmental funds.

#### 15. STREETSCENE

David Cupit attended the meeting representing Streetscene. Cllr Woodfine -Jones wished to express his thanks for all the work done in Bwlchgwyn, the cutting of the hedge at the War Memorial and old Post Office and the gritting of the roads throughout the winter. The new noticeboards had been ordered and Cllr Tilston put it to the Council that the old noticeboard would be left in place at the King's Head where the lanlord was willing for it to remain. This would save the Community Council in costs occuring with its removal. Cllr B Stapley proposed the motion and it was seconded by Cllr Woodfine-Jones . All Councillors were in favour. Cllr Tilston said a slab had been prepared in anticipation of the new litter bin by The King's head. Davis Cupit said that funds would be available in the the new financial year. Cllr Woodfine-Jones pointed out that the dog fouling bins had been placed on the incorrect 30mph sign in Bwlchgwyn. This would be addressed by Geraint Smith.Cllr B Stapley said that slabs had been damamged in Cheshire View by contractors working there, Dave Cupit would get these replaced. Cllr A Stapley mentioned that potholes needed filling in Pool Road also. Dave Cupit said that the surface was due to be resurfaced this year but would get the potholes filled in the meantime. Cllr Rogers said that there were also potholes in Edward Street that needed looking at. Cllr Wynne requested dog fouling signs be placed by the park in Tanyfron. Cllr Rogers said that he had met with John Bradbury and hopefully Streetscene representatives would attend the meetings more regularily. Cllr Tilston thanked Dave Cupit for his attendance.

#### 16. ANGLING CLUB

A letter had been received by the clerk re the lease of the Angling Club. The Angling Club wanted to know how much the rent would be after the first year at a peppercorn rent. The Community Council agreed that a meeting would be needed to discuss with representatives from the Angling Club re the rent. The clerk was to organise this.

#### 17. DONATIONS

A donation request of £100.00 was agreed by the Community Council for Llangollen International Eisteddfod

A donation request for £100.00 was agreed by the Community Council for Macmillan Nurses.

Ryan Rogers of Sports Association of Brymbo spoke and requested a donation towards the cost of cutting and marking the football pitches and also a very large water bill of £500.00 which had been received.Cllr B Stapley and Cllr H Williams declared an interest and signed the appropriate forms. Cllr Woodfine-Jones proposed a donation of £1500.00 and this was seconded by Cllr A Stapley. All councillors were in favour that the Community Council donate £1500.00 to the Sport Association of Brymbo.
