MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY 7^{th} JULY 2015 AT LODGE COMMUNITY CENTRE

The minutes of the meeting held on June 9th 2015 were confirmed as a true record and signed by the Chairman. Cllr Shone said that the peppercorn rent which was agreed on at the previous meeting should state that it would be £1 per week.

The Chairman told members that Councillor Mal Reston had passed away the previous week after a short illness. A minutes silence was held. The Chairman said that Cllr Reston would be remembered for his generosity and positive contribution to the Community and he would be greatly missed.

The Chairman told members that CBC Dave Kelly's mother had recently passed away and said his thoughts were with Cllr Kelly at this difficult time.

The Chairman passed on his thanks to the police for all their work on and around the previous steelworks site. He said their presence had been highly noticeable and he believed it had made a difference.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

The Chairman said that there were on-going discussions regarding the retail development and WCBC were involved. He said that there were going to be smaller units and these would be ideal for any local businesses that were interested in the site. Cllr Shone said that he was concerned about the increase in traffic volume towards the site. The Chairman said that this may reduce as local people would not then have to travel far for necessities that they previously would have had to drive to. The Chairman said that Brymbo Developments had originally said that there was no demand for business units however two local businesses had shown an interest. He had passed their details on to Brymbo Developments.

The Chairman said that a working group had been set up between Brymbo Enterprise Centre, the Church and the Heritage Group and other local groups to commemorate 25 years of the closure of the Steelworks. The Community Council had not been involved as yet. The Chairman passed around the first newsletter that had been produced which told them about all the events that were due to take place over the summer. The Chairman asked whether the CC would like to become more involved with the working group and pay for one edition of the newsletter as the other groups would be doing. Cllr Jones asked if they should make a request for funding as other groups did. The Chairman said that if this happened the deadline would pass as donations were discuss half yearly. Cllr Birch said he disagreed with spending money on the newsletter. Cllr Liberatosciol asked how the newsletter was distributed. The Chairman said that 5000 were going to be distributed by volunteers around the village. Cllr Griffiths said that members should not be quibbling about paying for one edition of the newsletter and should be supporting this. Cllr Tilston agreed and said the CC should be support the Chairman on this matter. Cllr Shone said that these were individual groups who had joined forces and they should therefore approach the CC and then a donation could be made. Cllr Rogers said that an e-mail had been sent to himself and the Clerk asking the CC to support the working groups during this commemorative year. Cllr Jones said she was not opposed to the idea. The Chairman said that they were not asking for a donation but the support of the CC for the event and as this was the last meeting prior to the event they requested that the CC fund one edition of the newsletter at a cost of approx. £250.00. The Chairman said that Church, Enterprise Centre, The Crick and Heritage group were all working together to support this. Cllr Liberatosciol proposed that the CC fund the one edition of the newsletter as she thought the CC should be actively involved in this project as residents would see this as a positive step in the CC becoming involved in activities of the village. Cllr Woodfine-Jones seconded the proposal. Cllr K Mathews declared an interest as a member of the Heritage Group. A vote was taken. 6 were in favour and 3 against. The motion was carried. It was agreed that representatives from the CC should also attend the meetings of the working group.

4. ROADS

The Chairman said that a resident had written to WCBC with regards to speeding on the new link road. They would be monitoring and reviewing the situation. A meeting was being held the next week to discuss repeater speed signage as the 30 mph did

not meet the guidelines for this type of signage. Also, the signs were presently covered and this was being addressed.

Cllr Shone again raised concerns about the speeding traffic on Coed Y Felin Road and said it was only a matter of time before there was a fatality there. PCSO Simister said he would look into this.

6. PLAYING FIELDS AND PLAYGROUNDS

The Clerk told members that the pitch fees for the Youth team were £12.00 per game. There had been difficulty in invoicing the team as fixtures were only organised on a monthly basis and these did not include cup games. Cllr Reston and Cllr Monti had previously kept the Clerk aware of how many times the pitch was being used for official games. The CC was now in a position of not knowing how many games were due to be played. The Chairman said that a decision needed to be made on charging procedure. He said it that a charging rate for the season could be decided and this would then take into account all matches played and training nights. Cllr Rawlinson proposed that a sum of £250.00 be charged for continued use for the season, paid in advance. This was seconded by Cllr Woodfine-Jones. A vote was taken. All were in favour.

7. FOOTPATHS/LIGHTING

Cllr Griffiths said that he had checked all the lights in Tanyfron and found that 26 were not numbered. Members agreed that Cllr Griffiths contact Jones Lighting and request that they carry out this work. Cllr Birch proposed that the sum each lighting rep. could sanction should rise from £200.00 to £300.00. This was seconded by Cllr Woodfine-Jones.

All were in favour.

Cllr Mathews had agreed to assist with Bronwens Green and now had a set of keys. The Chairman said that there was a need for a sub-committee meeting to discuss various items. He said this could be done before the next Council meeting in September. Cllr Prince had shown an interest in becoming a member of the sub-committee. The Clerk said that the junior football club was paying £12.00 per match at the moment; however there was no charge for training. The Club had a set of keys and could therefore play anytime and use the facilities. The clerk said it was difficult to keep track of matches played as Cllr Reston and Cllr Monti had always done this in the past. Fixtures were only printed one month in advance and no notice of cup games was given. Cllr Rawlinson proposed that a sum of £250.00 should be paid in advance enabling the team to use the facilities as and when they required. This was seconded by Cllr Woodfine-Jones, A vote was taken. All were in favour.
