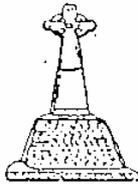

MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY NOVEMBER 8TH 2016 AT BRYMBO ENTERPRISE CENTRE.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

Cllr Kelly noted that there were no Councillors present from Bwlchgwyn. He told members that funding had been secured for the traffic calming project in the village. A public meeting had been held by the Residents Assoc. who had further plans for more interactive signs and road painting. Cllr Kelly was concerned as the residents who were in attendance wanted BCC to fund schemes in the village. He said that his understanding was that the Bwlchgwyn Councillors would come up with a project and this would be looked into further by BCC at a full Council meeting as had happened in the past with the TYF MUGA and Bronwens Green. Members agreed, as the Community Councillors were elected by their constituents to represent the views of the whole village and not just individual groups. Cllr Prince proposed, and Cllr Ashworth seconded that no scheme could be discussed for Bwlchgwyn until there were 3 Councillors representing the village. The Clerk said that there was still a vacancy as no-one had applied since Cllr Jones's resignation. As the Elections would be next May there was not now a need to fill the vacancy as with the resignation received from Marilyn Liberatosciol from Brymbo which the Clerk had received earlier that month. A vote was taken. All were in favour.

Cllr Rogers said that there were still issues with the new bin collections and requested that residents contact WCBC to let them know if there were problems in their areas. Cllr Rogers said that the issues with signage were nearly resolved. WCBC were waiting for costing as they needed 3 quotes for everything. The new street names would be arriving hopefully by the end of the week. Cllr Rogers said that he had met with the Play Assoc. and discussions had taken place on phase 2 of the improvements around the Skate Park. . WCBC were happy to support the path improvements however two quotes had been requested but the contractors had withdrawn. Cllr Rogers told members that the planning consultation process had begun for the new school and the timetable for that would hopefully be within six months. As it was classed as a major development there would be an opportunity for the CC to formally respond to the planning process. Cllr Roger said that he had received a letter from Donna Dickinson requesting that the CC help part fund a Youth Support service in the area. The Clerk said she had received this and circulated it to members. She had e-mailed Donna Dickinson requesting costings as the deadline she had been given was 16th November 2016. A letter had been sent to the Clerk which Cllr Rogers read out with the full cost of the service. The total of the contribution she was looking for would be £4058.00 which provided 1 x level 1 youth support worker at JNC point 5 (1x3 hour session (2.5 delivery) per week x 40 weeks at a cost of £1441.26 and a 1 x level 2 youth support worker at JNC point 11 1x3 hour session (2.5 hour delivery) per week x 40 weeks at a cost of £1794.56, plus a 10% (Maximum) management fee of £323.00 , plus recommended project costs of £500.00.

Cllr Rogers said that he was interested in supporting the project as evidence of a decrease in anti-social behaviour had been seen when the Enterprise Centre had held a weekly session. Cllr Rogers said that he had received an e-mail from Donna Dickenson later that afternoon saying that the situation had now changed and more details would follow. Cllr Prince proposed that the CC support the initiative in principle subject to various conditions be met which would be discussed when all the facts were presented to the CC. This was seconded by Cllr Mathews. All were in favour.

4. ROADS

Cllr Kelly said that the 30 mph speed limit had been extended on the Old Road up to Bwlchgwyn and the signage at the Moors junction was due to be completed soon. Cllr Rogers said that the re-surfacing of Heritage Way had commenced and upon taking off the top layer the second layer had deteriorated badly. This had caused further delays. BT contractors had identified works that needed to be done on Green Road that had not been planned and this was causing further delays to the re-surfacing there. He hoped the works would be completed by the next week.

5. BUS SHELTER SERVICES AND STOPS

6. PLAYING FIELDS AND PLAYGROUNDS

Cllr Mathews said that he had received two quotes to erect ball stop fencing around the football pitch. One was for supplying and erecting 27.5 L/Metres of 2 metre high double wire panel fencing with 60x60 posts, PPC green at £1650.00 & VAT. The other was for 3 no 70mm x 70mm steel posts and paint red oxide protection, securely fix diamond steel mesh fence to a height of 2.6 meters with a width of 1.8 either side of goal posts. Time and materials £1090.00 & VAT. Cllr Ashworth proposed that the quote for 1650.00 be accepted as it was in keeping with the work already carried out at Bronwens Green and the contractor had carried out other work on the site to a very high standard. This was seconded by Cllr Prince. All were in favour.

7. FOOTPATHS/LIGHTING

8. WAR MEMORIAL

Cllr Rogers told members that WCBC would be tidying the area around the War Memorial in Brymbo at no cost to the CC in preparation for Remembrance Sunday.

10. BRYMBO HERITAGE GROUP

Gary Brown from BHG presented members with a project overview and the 'Roots to Shoot' summary. (Copies attached). After the presentation he told members that a bid was to be submitted on the 8th December 2016 and they would hear at the end of March if it had been successful. He asked members if the CC would support the 1st phase of the project and if members would be willing to give the group a letter of

support. He said that the letter of support would be invaluable. The Chairman said that he would be happy to support the 1st phase of the project however the creative space project would be more difficult to support without more detail. Members agreed to meet with BHG before the next meeting in order to gain more information before a letter of support would be written. Members would report back to full Council at the next meeting. Cllr Monti proposed that a letter of support would be presented to BHG after the report at the next meeting. Cllr Prince seconded the proposal. All were in favour.
