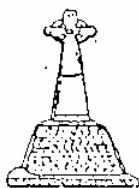

MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY 14TH FEBRUARY 2017 AT BRYMBO ENTERPRISE CENTRE.

The minutes of the meeting held on Tuesday January 10th 2017 were confirmed as a true record and signed by the Chairman.

2. POLICING

Members requested that there be more specific information on the crime stats. Cllr Rogers said he would feed this back to the police.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

CBC Kelly said that Darren Green of WCBC had said that the order for the traffic calming scheme in Bwlchgwyn had gone ahead. He hoped it would be started and completed in the financial year. He had also met with Denise Garland of WCBC regarding the issue of Bwlchgwyn Village Hall and the freehold of the land, and a report was being prepared to go before the Executive Board in March. There was a question of the suitability of the land that was to be designated to the St George's Field in Trust and this would need to be discussed further.

Cllr Rogers said that Hugh Jones of WCBC had supported a request for allocated officer time to assist with the Brymbo Heritage Group project (Visitor centre). There would be a further report to come back to the Executive Board. WCBC had endorsed the main project and would now delegate approval for officer time which could only be a positive thing. Members were told that the old school site had been put up for sale.

4. ROADS

Cllr Rogers said that he was due to meet with officers of WCBC to discuss the delivery of the one way order for Station Road, Green Road and Clayton Road. A consultation with residents was to be made. Cllr Shone said that at present the signage in that area was particularly confusing for drivers. Cllr Rogers said that WCBC were desperate to move on with the situation there. Cllr Rogers said that a letter had been circulated to Borough Councillors that afternoon confirming that the Communities First programme would end in 2018. He said that approx. 6 million of legacy grant would help with the continuation of the facility however there was a lot of concern.

Cllr Rogers said that the highway works on College fields was nearly completed and the adoption of the road was imminent.

5. BUS SHELTER SERVICES AND STOPS

Cllr Rogers was awaiting the quotes for the bus shelter near the Enterprise Centre. He said there were issues regarding the exact sighting of the shelter however he was hoping for a positive outcome. Cllr Davies asked if Cllr Rogers knew that the D Jones service in Tanyfron had ceased. He said unfortunately it had due to lack of usage, however he was in discussions with Arriva.

6. PLAYING FIELDS AND PLAYGROUNDS

Cllr Rogers said he had received the tender back re the path by the skate park, and he said it was very high at approx. £4000.00. Cllr Ashworth proposed and Cllr Shone seconded that two more tenders be sought. A vote was taken. All were in favour.

7. FOOTPATHS/LIGHTING

Cllr Rogers updated members on the lighting contractors who had re-located back to the Leyland office. He said that he had also received back the quotes he had requested a while back. Regarding the lighting in the car park at College Fields more than one lamp was necessary. Cllr Birch said that this was a safety concern. The quote came in at approx. £5600.00. Cllr Birch proposed and Cllr Griffiths seconded that the quotes be accepted and the lights be erected. This would come from the lighting budget. A vote was taken. All were in favour.

With regard to the quote requested for the Railway Road play area this was approx. £2200.00. Cllr Monti proposed and Cllr Rawlinson seconded that this quote be accepted and the work completed. A vote was taken. All were in favour. Cllr Rogers said that Jones Lighting had said that LED lighting were now cheaper than other forms and they would come back to him with proposals for changing the ageing concrete columns in the 3 villages.

8. WAR MEMORIAL

CBC Kelly said that the work to the War Memorial in Bwlchgwyn looked to be completed.

10. RISK ASSESSMENT

A copy of the CC's risk assessment had been circulated prior to the meeting for consideration. Cllr Shone proposed and Cllr Birch seconded that the current risk assessment be retained with no amendments as the document covered every need that members could see. A vote was taken. All were in favour.

Cllr Shone told members that there were still documents belonging to the CC in Cambrian House. Cllr Rogers said that he and Cllr Tilston would look at these and request that WCBC archive them.

11. SLA PLAY AREAS

The Clerk told members that she had received a new SLA agreement for the play area maintenance contract from WCBC for signing. She told members that costs had increased very slightly and much less than the previous year. Brymbo increase was £150.00, Tanyfron £31.00 and Bwlchgwyn £11.00. Cllr Ashworth proposed that members accept the SLA agreement. This was seconded by Cllr Birch. A vote was taken. All were in favour.
