MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY 9TH APRIL 2024 AT BRYMBO SPORTS AND SOCIAL COMPLEX.

The minutes of the meeting held on Tuesday 12th March 2024 were confirmed as a true record and signed by the Chair.

2. POLICING

The police had forwarded the crime statistics to the Chair prior to the meeting. Cllr Mathews said that he had reported vandalism and drug paraphernalia to the police that he had discovered on Bronwens Green. He was concerned that this was not classed as a serious crime. The Chair urged members to keep reporting all issues as these would then be logged and a trail would be kept. He also said that there had been attempted break-ins on the new Taylor Wimpey development as well as in residential properties.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

CBC Rogers said that the Executive Board had met that day and had discussed the building of the new school for Brymbo. He said that the next stage was to discuss the increase of pupil numbers from 154 to 210. The published consultation would hopefully be September 2024. He said that due to the timescale the numbers could well change again and that the plan was well behind schedule, however hopefully September 2026 would likely be the date of opening. CBC Rogers said that the lease for St. Mary's Church had been delayed until June/July. He said that he was in talks with WCBC regarding the Backie, and the priorities were Bronwens Green, Bwlchgwyn tennis courts and Brymbo Pool.

The Chair said that WCBC had removed the fencing as it was a Health and Safety hazzard and the cost to erect new fencing would be approx. 10-15 k. He said that he would look into placing a gate and ramp there if members thought this would help. All were in agreement.
