The minutes of the meeting held on Tuesday 14th June 2022 were confirmed as a true record and signed by the Chairman.

2. POLICING

The Chair had been sent the police report for the month.

Anti-social behaviour had decreased however there had been 1 arson incident. Police were increasing patrols in the area as cold calling and suspicious vehicles had been reported.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

CBC Rogers opened by saying that he had attended a meeting with Brymbo Developments regarding the steelworks site. WCBC would be submitting a planning application for the school site. The completion of the water pipe replacement works on the Council properties in the area was near completion. He had met with residents of Tai Owens who had identified various issues with the housing accommodation which would now be addressed. The Taylor Wimpey development was progressing however there had been issues with noise, dust and also mud in the wetter weather. The enforcement Officer at WCBC was keeping in contact with the developer. CBC Rogers said that the new road signs for Tanyfron and Bwlchgwyn had been ordered and were in production.

CBC Brown said that the LDP consultation closed on the 6th of July. He had noted 3 issues. Firstly that 419 sites had originally been looked at secondly the expansion of

the Ruthin Road site had been originally ruled out however there were plans to expand the junction nearby which could mean re-visiting this as a possible solution to increase the capacity of this site and thirdly the scoring process that had originally been used could be revisited as GP services and the Post Office service had now changed. CBC Rogers said that the CC were continuing to fund a Barrister and solicitor who were advising the CC on the proposed LDP. This advice was being shared with Cllr's. CBC Brown said that he had been reassured that the funding for the school site was still intact. He said that in his election campaign he had focused on the charitable status of the Enterprise Centre and would be looking at bringing it in line with other similar buildings in the Borough that were being subsidised. CBC Rogers declared an interest as he was a trustee of the Enterprise Centre. He said that there had been no discussions regarding future funding of the Centre. CBC Wellens said that there had been issues with the travellers site in Bwlchgwyn however when planning officer had attended there were no infringements to report. The situation was being monitored. He had been around the village and noted that roads and verges needed to be tidied. He was also meeting the Housing Officer to look at work that was needed on the Council properties in the village. The Chairman said that Cllr McNeil/Marsh would be asked to pass on the locations to CBC Wellens of all the new litter bins and grit bins that were to be purchased from the village/environmental fund.

7. FOOTPATHS

Cllr Griffiths said that the steps and handrail from the bridleway to the allotments needed attention. Cllr Ashworth said that she would assist with this. He also said that potholes along the bus routes had become an issue. CBC Rogers said he would look into this.

8. WAR MEMORIAL/LIGHTING

The Chairman said that the re-furbishment of the War Memorial; was due to begin that week. He had contacted two further companies for quotes for the lighting contract as he had not received an answer from the third one, however these had not replied as yet. The Christmas lights and Remembrance Day would be discussed during the summer recess and delegated to ensure completion of the work in time for winter. The Chair asked that funding form the Village Fund/Environmental fund be allocated to assist with the switch on event as it had been successful last year.

9. PLANNING

No planning applications had been received.

10. QUARTERLY ACCOUNTS

.A copy of all income and expenditure was circulated to members. The Chair and Clerk signed the bank reconciliation.

11. DONATIONS

Friends of St Mary's Church

A donation application had been completed and returned to the Clerk along with the required documentation from the above requesting financial support in a new campaign to buy a slate with a view to raising vital funds towards repairing the Church roof. Cllr Prince proposed and Cllr Mathews seconded that the sum of £500.00 be granted to the organisation. A vote was taken all were in favour.

A second application form had been received however the required documentation had not been submitted and the name of the organisation had not been completed. The Clerk had e-mailed the gentleman concerned however had not received an answer prior to the meeting.

12. CORRESPONDENCE

WCBC –COMMUNITY YOUTH WORK SLA-ADVICE OF INCREASE WCBC had notified the Clerk that the SLA for the Youth Service was to be increased by 1.75% in line with the cost of living increase. It would increase from £16949.00 to £17245.00.Members confirmed this was acceptable.
