MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY 11th FEBRUARY 2025 AT BRYMBO SPORTS AND SOCIAL COMPLEX.

The minutes of the meeting held on Tuesday 14<sup>th</sup> January 2025 were confirmed as a true record and signed by the Chair.

Police reports for all three villages had been received and circulated to members prior to the meeting.

## 2 COUNTY BOROUGH COUNCILLOR'S REPORTS

No report had been received from CBC Brown or Wellens.

CBC Rogers said that work was underway at the fossil forest. There were developments with the school site as a contractor was going to be appointed. WCBC'S environmental and highways department were repairing the retaining wall on Blast Road and Coed y Felin Road. Llewellyn road was on the list for resurfacing. CBC Rogers said that he and the Vice Chair had attended a meeting with BHT to put together a programme of events for the 35<sup>th</sup> anniversary of the closure of the steelworks. These included the involvement of local schools, daytime events, annual reunion events and Brymbo Rocks event. The community would be requesting a financial contribution from the CC nearer the time. CBC Rogers said that a new access had been created at Pentre Vron farm and a hedgerow removed. WCBC had issued a stop notice with dates to remove all rubble and waste and to replace the hedgerow. The Enterprise Centre would be celebrating 20 years with an event on 06/03/2052 with members invited.

CBC Rogers told members that WCBC had received a sum of money which could be distributed throughout the County to groups. The launch for application process was due the next week. Members agreed to set up a sub-committee with delegated authority to decide on applying for a specific project in the community.

CBC Rogers asked whether members would be agreeable to funding room hire for the upcoming VE Day Celebrations at the Enterprise Centre. Members said they would be happy to fund this. He had also received requests to fund a Halloween event. He would bring this back to a future meeting.

#### 6. RISK ASSESSMENT

The Clerk had circulated copies of the risk assessment prior to the meeting. Members were satisfied with the document. Cllr Martin proposed, and Cllr M Peacock seconded that the risk assessment be approved. A vote was taken. All were in favour.

#### 7 BVHA

The Clerk had told members at the last monthly meeting (14/01/2025) that a bank error had caused a payment of £1490.78 to be credited twice to BVHA on 07/01/2025. As a result, she had contacted them on 13/01/2025 and 14/01/2025 to request that the payment be refunded. She had received an answer on the 14/01/2025 to say that it would be refunded when the treasurer had time to contact the bank. By 17/01/2025 the payment had not been credited, therefore the Clerk contacted the bank who told her they would begin the process of attempting to retrieve the funds as she had already contacted the payee who was aware of the error. She was told that this could take up to a month. On 10/02/2025 the funds were credited back into the account of Brymbo Community Council. The bank contacted the Clerk to tell her that they had needed to reclaim the funds through BVHA's bank under the recovery . Members felt disappointed that the funds had not been refunded earlier when the error had first been reported to BVHA.
